Описание: The aim of this procurement is to reduce transport emissions in Oslo by using electric power banks. There are, therefore, absolute requirements for the environment for both the product and for transport in connection with delivery and service. The power banks shall be electric, and the supplier shall only use vehicles that are either zero emission vehicles (100 percent electric or hydrogen) or biogas vehicles that at least fulfil Euro class 6/VI. This applies for the last transport route, also referred to as "last mile", for delivery and for any service assignments. Due to these contract requirements, we will not have an environment as a separate award criteria in the competition. After an overall assessment we believe that further environmental criteria will not add value, as environmental considerations have already been taken care of through the requirements for product and transport. This is in accordance with the Public Procurement Regulations (FOA) § 7-9, which allows for exceptions from the

obligation to weight the environment when consideration is taken care of by other requirements that will give a better environmental effect than if the tenderer, for example, can choose to offer as environmentally friendly transport as the minimum requirement.
