Delivery may be performed by either Bechtel or company, as determined by Bechtel. Award will be made to the responsive and responsible company whose proposal meets the requirements of the RFQ and provides a technically acceptable proposal. Consideration of the following key criteria, together with cost, will determine the final decision for award(s), which will be detailed further in the Bid Document(s) and during the RFQ phase. a. Technical Capability b. Previous Proven Relevant Experience c. Quality d. Delivery Management Team e. Schedule The evaluation factors to determine the selected proposal shall be based on the commercial factors that impact overall cost, such as freight, proximity to project site, Carbon Border Adjustment Mechanism (CBAM) requirements, payment terms, performance and payment securities, and insurance. Buyer may divide the award among more than one Supplier if this is in the best interest of Buyer. Supplier must specifically list in their proposal all the country(ies) of origin for each major component.
