Описание: The starting point is that the contracting authority in the notice obliged procurements that weight the award criteria, shall weight climate and environmental considerations with a minimum of 30%. If the contracting authority sets the award criteria in prioritised order, climate and environment considerations should be among the three highest prioritised. The award criteria can be replaced or combined with climate and environmental requirements in the requirement specification, if this gives a better climate and environmental effect, and this is justified in the procurement documents, cf. FFO § 7-9 second paragraph. If climate and environmental considerations are not used as the award criterion in accordance with § 7-9 second paragraph, the contracting authority can also choose tender offers on the basis of the lowest price or the lowest cost, cf. FFO § 14-1 first paragraph. In this procurement it is chosen to replace the award criteria with climate and environmental requirements in the contract. The contract will be awarded on the basis of which tender has the lowest price. In accordance with Oslo municipality's standard climate and environmental requirements for transport, the tenderer is basically obliged to use only machines and vehicles, which are either

emission free (i.e. 100% battery electrical or hydrogen) or biogas operated and which as a minimum fulfil Euroclass 6/VI in the execution of the contract. The requirement applies for both the last transport stretch (cargo mile) to the contracting authority's locations and for operation at the locations. Based on an immature market, it is considered most appropriate to set minimum requirements for the use of bio-fuel in connection with the execution of winter operation and sweeping in this procurement. The use of bio-fuels is assessed as unproblematic and it creates a significant reduction in greenhouse gas emissions compared to fossile fuels. Other machines and vehicles shall be emission free or biogas based.
