Popis: This procurement concerns the procurement of services in statistics and calculation mathematics. The contract shall cover the contracting authority's need for the mentioned services and it will include, but is not limited to: Modelling of computer simulation studies Under support and further development of statistical and mathematical models.

Hlavní prvky řízení: The work will be associated with several projects, where the tenderer must be able to forward, transfer and present work connected to the contract. The tenderer's resources connected to the contract shall work in an integrated research team together with the contracting authority's researchers and must be able to transfer competence to the Contracting Authority's employees. The contract shall be used in connection with several established and future projects and their models at the Contracting Authority. The work will particularly deal with: SAM (fishfollower/SAM: Git page for SAM R-package), an assessment model used in the stock assessment of all of Norway's largest and most important stocks (i.a. in the ICES context and for benchmarks and assessment within Norwegian-Russian cooperation). The contracting authority needs competence to assist in use, as well as to further develop and adapt the model to the contracting authority's needs. Furthermore, there is a need for the development and use of several stock models for fish and marine mammals, which can handle uncertainty, spatial and temporal variation and complex sampling design. This also includes the development of criteria for model validation and model selection, as well as harvesting rules that explicitly take into account uncertainty (variance and bias) in stock estimates. An expanded bioacoustic model shall be developed that can monitor fishing grounds and support decisions on closure/opening, based on both the number and size of the surveyed fish and shrimp. This is based on a preliminary project from 2026. Further work includes the development of prediction routines, thorough validation, handling of spatial varying minimum

targets and the establishment of a user interface for the Norwegian Institute of Marine Research, the Directorate of Fisheries and the Maritime Service. The above requirements are not exhaustive.
