The scope of work shall include design, material/equipment that meets scope of work, specification, and other purchase order requirements. Delivery may be performed by either Bechtel or company, as determined by Bechtel. If Company has any questions or to express interest in bidding this requirement, Company shall notify Bechtel's Contact Person.
