Hovedpunkterne i proceduren: The procurement will be carried out as a negotiated procedure after a prior prequalification. The contract will be signed as a turnkey contract in accordance with NS 8407. Tenderers shall offer a house concept that is part of the turnkey contract.

Tenderers shall, themselves, or through associated sub-suppliers and collaboration partners, document the necessary competence and capacity to deliver a complete turnkey contract which includes, among other things, site development, engineering design services and safeguarding the role of responsible applicant, as well as execution of the necessary construction and construction work, which i.a. also includes foundations, ground works and outdoor work. The background for the competition is a wish to use tested and cost efficient solutions based on ready developed housing concepts that can be adapted to the relevant

sites and the user groups' needs. Bærum municipality has previously had good experience with this approach, and assumes that the tenderer offers systems that as far as possible are based on documented and well-tested concepts.
