Hovedpunkterne i proceduren: The procurement procedure is a negotiated procedure as defined in the Finnish Act on Public Contracts in the Fields of Defence and Security (1531 /2011). The estimated value of the procurement is over the European Union threshold value for services. In negotiated procedure, any economic operator may submit a request to participate in response to an invitation to participate by providing the information for qualitative selection. Only those economic operators accepted by the Contracting Authority may submit a preliminary tender and participate in the negotiations. The Contracting Authority will invite the selected candidates to negotiations. The purpose of the negotiations is to explain in further detail the requirements of the services, to give the tenderers a possibility to comment on the scope of work as well as the commercial conditions provided therein. The participating parties to the negotiations are therefore given the possibility to develop the assignments further in order to achieve the optimal final result. The object and scope of the contract shall be defined in the procurement documents. During the negotiations the scope of the contract will be

elaborated and specified further. The final scope of the contract will be provided with the final invitation to tender to be issued after the negotiations. The Invitation to participate and the procurement documents are available in English. The request to participate shall be in English. The Contracting Authority has right to change the procurement language to Finnish in invitation to tender, if all selected tenderers agree to this. The Contracting Authority may decide to discontinue the procurement procedure at any time, without awarding the contract. Such a decision may be adopted in accordance with the Act on Public Contracts in the Fields of Defence and Security. No compensation, costs or expenses shall be paid to candidates should the Contracting Authority decide to discontinue the procurement procedure or otherwise. The Contracting Authority will not pay any compensation for participating in the procurement. All costs, expenses and liabilities incurred in connection with preparation and submission of the request to participate, negotiations, tender(s), travelling, meetings and any other documentation will be borne by the candidate/tenderer, regardless of the conduct or outcome of the procurement procedure.
