If the tenderer does not have such internal competence, it shall be collected externally and invoiced at the contract's ordinary hourly rates without mark-up or extra costs for the contracting authority. Tenderers shall act as a proactive consultant and actively choose environmentally friendly materials and energy efficient systems with a long lifetime to ensure good operational security and a low environmental impact. The agreement shall take care of both planned assignments and acute needs, with requirements for a quick response time.
