Experiences from 2025 show, among other things, handling approx. 550 course packages and 50 standard packages, transport to and from around 50 course locations, and storage of 180-220 pallets. All deliveries under this contract shall be carried out either with zero emission vehicles (battery electric or hydrogen) or with biogas vehicles that at least meet Euro class 6 /VI. In addition materials recyclable packaging, preferably cardboard or paper are required.
