The maximum contract length is 8 years. The estimated value of the framework agreement is NOK 1 million per annum. At the maximum contract length, the estimated value is NOK 8 million. The maximum total value of the framework agreement is NOK 12 million due to the expected price growth in the period as well as unforeseen events that may require more frequent use of the service.
