Based on historical figures, the total procurement is estimated to have a value of NOK 22 million over the framework agreement's 4 years. The actual volume can vary from year to year. The estimate is not binding for the contracting authority, and changes in the financial or political framework terms can lead to the estimated number of assignments being increased or reduced. The agreement will be valid for a maximum call-off of up to NOK 25 million during the agreement period.
