Regarding the assignments that the tenderer designs for the Contracting Authority, it is primarily the Contracting Authority's used furniture that shall be used, or furniture in the joint governmental DFØ contract for the procurement of office furniture that the Contracting Authority is connected to, where there are considerable requirements for climate and environment. The Norwegian Public Roads Administration is therefore exempt from the obligations to weight the environment 30% or to prioritise the environment among the three highest prioritised award criteria.
