Beskrivelse: Ydelsen omfatter lovpligtig revision og påtegning af årsregnskaberne for Metroselskabet I/S og Hovedstadens Letbane I/S. Der er således tale om to særskilte revisionsopgaver, som udbydes samlet, samt revision af de til enhver tid eventuelle datterselskaber af Metroselskabet og Hovedstadens Letbane. De nuværende datterselskaber af Metroselskabet, Komplementarselskabet København Syd By ApS og København Syd By P /S, forventes overdraget primo 2027. Revisionen omfatter endvidere de erklæringer, specialregnskaber, opgørelse og indberetninger m.v., der i henhold til den til enhver tid gældende lovgivning skal forsynes med særskilt revisionspåtegning. For Metroselskabet gennemføres revisionen i samarbejde med Rigsrevisionen, som er udpeget af staten. Rigsrevisionen og Metroselskabets udpegede revisor har et fælles ansvar for den samlede revision, afgiver en fællespåtegning og revisionsprotokollat. Revisorerne aftaler den nærmere fordeling af opgaverne. Opgavefordelingen i de seneste år har været, at den af kommunerne (Københavns Kommune og Frederiksberg Kommune) udpegede revisor har varetaget den finansielle revision, mens Rigsrevisionen har varetaget den juridisk-kritiske revision (SOR 6) og forvaltningsrevisionen (SOR 7). For Hovedstadens Letbane gennemføres revisionen udelukkende af den udpegede revisor. Metroselskabet har etableret en Revisions- og bæredygtighedskomite, hvor der afholdes møde tre gange om året. Rigsrevisionen og selskabets udpegede revisor deltager i disse møder. Der er ikke etableret en tilsvarende komité i Hovedstadens Letbane. I begge selskaber deltager revisorer som udgangspunkt i 1-2 bestyrelsesmøder årligt. Herudover omfatter ydelsen sædvanlig, kortvarig assistance og rådgivning i tilknytning til revisionen, herunder besvarelse af telefoniske og øvrige løbende forespørgsler om regnskabsmæssige forhold. Revisionen skal udføres i overensstemmelse med de til enhver tid gældende danske og internationale revisionsstandards, og revisor er i forbindelse med opgavens udførelse forpligtet til at holde sig orienteret om relevant national lovgivning, EU-regelsæt samt øvrige regler og standarder af betydning for revisionsopgaven.
