Beschreibung: The aim of the procurement is to be able to offer free user choice to home nursing users, so that users can choose between public or private service provision.

Zentrale Elemente des Verfahrens: The aim of the procurement is to be able to offer free user choice to home nursing users so that they can choose between public or private service provision. Malvik Municipal Council decided in 2025 to introduce free user choices for home care and home nursing during April 2026. This competition is for free user choice for home nursing care. The scheme concerns service recipients of district nursing care in Malvik municipality who live in their own home. The scheme does not include service recipients who live in residences where there is permanent staffing. Users of the service who do not wish to use free user choices or who do not make an active choice, are awarded assistance from the municipal service. [KS1] [KS2] [DK3]The tenderer can offer additional services to the user. Additional services are services beyond what the user has received individual decisions on from the municipality. It will be possible for users on their own initiative to order additional services from the private service provider who will be awarded the assignment. Additional services are not included in the municipality's responsibilities in accordance with the Municipal Health and Care Services Act. These services are not part of the contract. The user pays for these services themselves and it is voluntary for the users whether they want additional services or not. The payment and rates for additional services purchased from the supplier are a relationship between the service provider and the user. There are currently approx. 196 inhabitants in Malvik municipality who receive home nursing care.
