It is structured in three sections: (i) Kumanovo to Beljakovce (Phase 1, 30.8 km) currently in DLP, (ii) Beljakovce to Kriva Palanka (Phase 2, 34 km) presently under construction and Kriva Palanka to Deve Bair (Phase 3, 22.1 km) - this segment leads towards up to the cross-border tunnel with Republic of Bulgaria. This procurement notice refers particularly for the section “Construction of new railway section from Kriva Palanka to the cross-border tunnel with Republic of Bulgaria”. The objective of the assignment is supervision for construction of a single-track electrified railway line from Kriva Palanka to the cross-border tunnel (Phase 3), signalling and telecommunication for Phase 3, as well as electrification of the line from Kumanovo to the border with the Republic of Bulgaria (Phase 1, 2 and 3).
