The service is voluntary for the prize winner, but Norsk Tipping wants to ensure that those who want it get sufficient information and good advice connected to winning a larger cash prize. At the same time, it is important that the winner understands different aspects of winning a bigger prize, so that they experience safety in their new situation and get the most enjoyment of the cash prize. The requested service is mainly economic and legal guidance. Tenderers shall not give concrete advice on cash placements in named and specific objects. The focus is on advice on a suitable general basis. I.e. the guidance shall be individual and take the starting point in each individual's life situation, personal finances, wants/needs as well as the size of the premium.
