1) Justification for the choice of the negotiated procedure without prior publication of a contract notice in the OJEU in accordance with Directive 2004/18/EC

The works, supplies or services can be provided only by a particular economic operator for the following reason:

The Torpedos, Tomahawk and Harpoon Project Team, part of the UK Ministry of Defence, proposes to let a contract for the production and supply of Hydroxyl Ammonium Perchlorate (HAP) with EPC-UK in support of Spearfish Torpedo activities. The duration of the contract will be 3 years for Production/Storage/Delivery activities. It is considered that this contract can be placed using the negotiated procedure without prior publication pursuant to Article 28(1)(e) of Directive 2009/81/EC (Regulation 16(1)(a)(ii) of the Defence and Security Public Contracts Regulations 2011). This is due to technical reasons. Due to the complexity of the equipment and with no data pack being available to the Authority, it is considered to be technically impracticable for any potential contractor to dismantle, relocate and reassemble the production facility (which is constructed entirely of glass) and gain the required level of expertise and knowledge required to produce HAP to the high standard specification from the outset of the contract. This would create an unacceptable risk to the capability of the Mod 0 Spearfish torpedo programme as any new contractor would not have sufficient immediate knowledge to ensure that the UK Ministry of Defence receives a quality and HSE (Health and Safety Executive) approved product.
