The contracting authority will collect the relevant Company Registration Certificate from the Register of Business Enterprises. Foreign tenderers must attach certificate that prove they are a legally established company and that they are registered in the professional registered as determined by the law of the country in which the tenderer is established. The requirement for tax and VAT certificate means that tenderers with company addresses outside of Norway must submit certificates that confirm the tenderer has their tax and duty payments in order in their homeland. The certificate shall be issued by a public authority with permission to issue these certificates. If a tenderer's home country does not issue such documents or certificates, they can be replaced by a declaration given under

oath or affirmation by the relevant person to a legal or administrative in the home country or current country of residence, a notarius publicus or other competent authority in the home country or current country of residence.
