The owner municipalities in Indre Østfold Data IKS (IØD) currently has separate telephony systems of varying age and quality. IØD would like to establish a framework agreement with one supplier for procurements of a joint telephony system for the owner municipalities. The telephony system can be offered for installation in the awarding authority's premises or as a "cloud system". The framework agreement shall include the central system, user equipment, migration and services plus a number of options.

The municipalities are free to use the contract in the contract period.

II.2. Scope of the procurement

II.2.1. Total quantity or scope

A fully developed system must be able to serve just under 2000 subscribers with up to 200 simultaneous conversations. However only Askim municipality shall migrate and be connected to the new system from the start. Hobøl and Skiptvet municipalities will probably also join the system during the contract period, whilst Eidsberg, Spydeberg and Trøgstad municipalities have relatively modern telephony systems and are more uncertain.

The supplier shall be able to provide these services if the awarding authority has a need for them in the framework agreement period. The services shall be priced in the tender form. In short these will be:

 16. Internal subscribers shall get an engaged signal when they call another internal subscriber who is engaged in a conversation;

 19. Other functionality (we encourage good, useful and user friendly systems that are suitable for our largest user groups).
