The Contracting Authority also reserves the right to procure the development by alternative means if it appears that the development can be thereby more advantageously procured. The lowest or any tender will not necessarily be accepted.

The funding agency, the Department of Education & Skills is subject to the requirements of the Freedom of Information Act.
