Indien de aanbieder gebruik maakt van post-processing data reductie, mag men geen reductiefactor in rekening brengen. De aangeboden storage capaciteit moet minstens 80 % meer beschikbare ruimte aanbieden om de groei de komende jaren deels op te vangen.
