Main site or place of performance: This 1.9 hectare site is located at Carnmoney Road, Glengormley and comprises the buildings and curtilage of a former Tesco store and associated retail units. Access to the land is from Carnmoney Road. There are 2 points of

access into the site from Carnmoney Road to the east, 1 towards the north which provides access to the service yard and rear yard, and 1 shared access towards the south which provides access to the car park to the front. This access is also used by Glengormley Community Services Centre and Glengormley Branch Library.

The existing building occupies much of the site with the balance of the land comprised of a parking court to the east, a service yard to the north and an additional hardstanding area to the west. The curtilage of the site is defined by 0.5 metre high concrete bollards to the east and partly to the south and timber fencing to the north and west. The remainder of the southern boundary is undefined. The land within the site is generally flat.

The surrounding area is primarily residential in character and comprised mainly of 2 storey semi-detached dwellings to the north, west and east. Glengormley Community Services Centre and Glengormley Library is immediately adjacent to the south of the site with Glengormley Park beyond.

The proposed mix for the scheme is 56 units comprising 10no. 1b/2p GN apartments, 12no. 2b/3p GN apartments, 11no. 2b CAT1 apartments, 16no. 2b/3p houses, 6no. 3b/5p houses and 1no. 4b house. The building will be constructed to Lifetime Homes and Secured by Design standards.
