The purpose of the GPET-E contracts is for each supplier of GP clinical IT systems to develop the software needed to safely extract and communicate data from (a) practices that use their systems to (b) the NHS Information Centre for Health and Social Care. This is part of a wider project to bring together primary care data that exists in different GP practice systems and present it in a single and consistent format. Also, the GPES and GPES-I Interoperability Standard shall be the means by which Mandatory Extractions (including but not limited to data returns for the Calculating Quality Reporting Service), as may be required under the powers of

the Health and Social Care Bill, are delivered to the NHS Information Centre for Health and Social Care.

The Authority applied a derogation available under Regulation 14(1)(a)(iii) of the Public Contracts Regulations 2006 to enable the direct award of the contract without a regulated competition. Regulation 14(1)(a)(iii) provides that where, for "technical or artistic reasons, or for reasons connected with the protection of exclusive rights" there is only one possible supplier of the relevant services then a direct contract award without a regulated competition is permitted. It is the Authority's view that the award of the contract to a General Practice System of Choice (GPSoC) supplier i.e. Egton Medical Information Systems Limited is for reasons connected with the protection of exclusive rights and that GPSoC suppliers are the only providers who can produce the outcome required. GPSoC suppliers have exclusive access to, or rights over, the source code of the key software and as a result: a) it is not technically possible for the work to adapt the existing solution for GPET-E to be undertaken by an alternative supplier; and b) where it is technically possible, if the Authority permits an alternative supplier to (for example) modify, configure or build upon the GPSoC system software, this may breach the software licence terms and/or adversely affect the GPSoC Compliant System status of the existing software.
