Udbygning af afløbssystem Langelinie omfatter ændringer og udbygning af eksisterende ledningsanlæg og bygværker i og omkring vejen Langelinie. I alt er der tale om et kloakeret område på 144 ha.

I hovedtræk består dispositionsforslagets vedtagne alternativ af en ny transportledning i Langelinie og opdimensionerede ledninger i en række sideveje. I alt ca. 8 km. ledninger. Det drejer sig i stort omfang om ledninger i dimensionerne ø800 - ø1 400 mm. I mindre omfang drejer det sig om ledninger i dimensionerne ø300 - ø700 mm. Desuden 2 pladstøbte bassiner på henholdsvis 1 100 m³ og 2 500 m³ inkl. skyllesystem og mekanisk rensning af opspædet spildevand. 9 overløbsbygværker skal nedlægges og erstattes af 2 nye overløb til Odense Å. Nogle ledningsarbejder forventes udført ved opgravning og tunnelering, andre ved strømpeforing, rørsprængning og styret boring.

På det pt. foreliggende grundlag er det hensigten at udvikle et partnersamarbejde mellem VandCenter Syd, en udvalgt rådgiver og en udvalgt entreprenør. Partnersamarbejdet skal stå for den endelige optimering, projektering og udførelse af udbygningen. VandCenter Syd vil selv stå for hydraulisk optimering samt el og SRO arbejder.
