Extreme urgency brought about by events unforeseeable for the contracting authority and in accordance with the strict conditions stated in the directive.

Der plötzlich stark angestiegene Zustrom von Asylsuchenden stellt die Hansestadt Rostock vor große Herausforderungen. So müssen die unmittelbaren Bedürfnisse der Asylsuchenden angemessen und zügig sichergestellt werden. Darunter fällt auch die Ausstattung der Unterkünfte gemäß Verordnung über die Mindestanforderungen an Art, Größe und Ausstattung von Gemeinschaftsunterkünften. Nachdem Mitte September die Anzahl der Flüchtlinge sprunghaft angestiegen ist, mussten die Versorgung und Unterbringung umgehend organisiert werden. Die Akquise von Immobilien, der Neubau in der Satower Str. und die Containereinrichtungen Satower Str. wurden eilig vorangetrieben. Anschließend ist die Ausstattung der Unterkünfte erforderlich. Die Dringlichkeit ergibt sich auch daraus, dass ständig neue Zuweisungen von Flüchtlingen durch das Land erfolgen. Die Flüchtlinge müssen schnell einer Unterkunft zugewiesen werden.
