Credit rating equivalent to score A (credit worthy) or better, measured on the Bisnode Norge AS AAA rating system, or equivalent score from other reputable credit rating agencies. The rating must be based on the last known accounting figures and it must be carried out by a credit information agency with permissions thereof. Newly started companies with a credit rating of AN, individual foreign companies or companies without reporting obligation to the Brønnøysund Register Centre will not always be able to submit a credit rating as documentation that the qualification requirement is satisfied.
