Bauliche Erweiterung und Umbaumaßnahme der Radiologie am Standort Klinikum Nürnberg Süd.

Die Maßnahme gliedert sich in drei Teilbereiche, die Errichtung einer neuen Technikzentrale im U3 (U1 im Verhältnis zur Feuerwehrumfahrt) unter der Feuerwehrumfahrt neben dem Wirtschaftshof. Die Erweiterung der Radiologie um zwei MRT's im U1 (1.OG im Verhältnis zur Feuerwehrumfahrt) auf dem Dach der Lagerbereiche Küche und die Erweiterung der Kältemaschinen im 3.OG mit Anschluß an das Kältenetz des Gesamtklinikums. Die Baulichen Eingriffe im 3.OG sind minimal.

Ein Großteil der Trockenbauarbeiten wird in der Ebene U1 erbracht, hier werden neue Trockenbauständerwände in F0 und F90 Qualität errichtet, sowie Vorsatzschalen und Trockenputz in der Vertikalen. Die Decken in dieser Ebene sind primär GK-Decken, teilweise in Akustikausführung und Flurdecken. Auch die Türen gemäß der beiden Tür-Lose werden primär in diesem Geschoss eingebaut.
