Uudisrakennus n. 8 000 brm2 toteutetaan kahdessa (2) vaiheessa ja rakennustyöt alkavat kesäkuussa 2019. Ensimmäisessä vaiheessa rakennetaan n. 4 000 brm2:n uudisrakennus, joka valmistuu keväällä 2020. Toisessa vaiheessa puretaan osa vanhasta rakennuksesta sekä rakennetaan uuden ja vanhan rakennuksen väliin n. 4 000 brm2:n uudisosa, joka valmistuu keväällä 2021.
