It would be highly desirable if respondents were also able to offer advice and representation in relation to employment law, contract law, information law, prosecutions, and anti-money laundering law. The Commission may also need ad-hoc advice from time to time on other legal areas. It is intended that legal representatives will be appointed to the panel for an initial period of 3 years, with the possibility of renewal on an annual basis up to a maximum of five years in total.
