Porsgrunn municipality has decided to construct the New Brevik Childhood and Youth centre which will include a primary school, from the first grade, to and including the seventh grade, a five department nursery school, as well as a multi-purpose hall connected to the existing sports centre, pavilion 8.

The primary school from the first grade up to and including the seventh grade The school is designed for a approximately 200 students. The nursery section is designed for 82 children

divided between 5 departments. A new sports centre shall also be constructed. The internal measurements of the centre are 24 x 35 metres which can be divided into a basic hall (gymnasium) and a hall with a free game area. The sports centre shall be constructed, connected to the existing Pavilion 8 (a sports centre) which also includes a swimming pool, locker rooms and premises for Brevik Sports Club (clubrooms).
