Denna upphandling avser resor för elever vid riksgymnasierna för svårt rörelsehindrade ungdomar (Rh).

Bland de studiestöd som CSN administrerar finns det så kallade Rg-bidraget. Detta regleras av en förordning där elevernas resande är reglerat. Bidraget lämnas bland annat för kost, logi och hemresor till elever vid riksgymnasierna för döva (RGD) och hörselskadade (RGH) samt till elever vid riksgymnasierna för svårt rörelsehindrade ungdomar (Rh).
