Nokian kaupunki kilpailuttaa Siuro-Linnavuoren alueen uuden päiväkodin uudisrakennuksen jaettuna urakkana; rakennusurakka pääurakkana ja talotekniikkaurakat alistettuina sivu-urakoina. Siuro-Linnavuoren uuden päiväkodin rakennuspaikka sijaitsee osoitteessa Siurontie 8, Nokia. Päiväkotia rakennetaan tällä hetkellä tyhjillään olevalle Nokian kaupungin omistamalle tontille. Päiväkodin tilat on mitoitettu 126 päiväkotilapselle ja noin 30 henkilökunnan jäsenelle. Kohde toteutetaan pääosin hirsirakenteisena. Hankkeessa noudatetaan kosteudenhallinnan Kuivaketju 10 -mallia ja puhtaudenhallinnassa P1-puhtausluokkaa.
