Bergen Maritime Museum plans to replace some of the windows at Haakon Shetelig's plass 15. This is work that must be approved by the Cultural Heritage Management Office and this process has started per 14.02.2020. The building is a brick building that has large historical and architectural value. The windows on the administration wing are to be replaced. This work includes, amongst other things, carpentry, painting, flashing and guttering, and masonry work. A general contract form has been chosen and the contract formula will be NS8405. The work is scheduled to start in April 2020, with completion expected in June 2020.
