Tampereen maauimalaan toteutetaan laaja allaskokonaisuus, joka koostuu yhdestä 50 m pitkästä altaasta, jossa 8 rataa, 25 m pitkästä hyppyaltaasta (10 m hyppytorni) sekä noin 300 m² laajuisesta lastenaltaasta ja pienten lasten kahluualtaasta. Lisäksi uimalaan rakennetaan myyntitilat kahvila/kioskille ja pukeutumiselle ja peseytymiselle.
