Op grond van artikel 31 lid 2 sub b Bao gunt het UMC Utrecht aan ItéMedical; levering van bewakingsmonitoren aan divisie Kinderen. Voor de patiëntveiligheid binnen het UMC Utrecht is het noodzakelijk dat in het UMC Utrecht zoveel mogelijk met dezelfde apparatuur wordt gewerkt. De kans op fouten in de patiëntenzorg neemt immers toe wanneer medisch en verpleegkundig personeel wordt geconfronteerd met een diversiteit aan apparatuur. Naast deze overweging van patiëntveiligheid speelt de overweging mee dat het onderhoud en beheer beter geborgd kan worden wanneer de diversiteit aan apparatuur verkleind wordt. Ook dit verlaagt de kans op fouten. Conclusie is dat door de leverancier ItéMedical te verrichten aanvullende leveringen van bewakingsapparatuur gerechtvaardigd is, aangezien veranderingen van leverancier het UMC Utrecht ertoe zou verplichten apparatuur aan te schaffen met andere technische eigenschappen, zodat onverenigbaarheid ontstaat en zich bij gebruik onevenredige technische moeilijkheden zullen voordoen.
