It is envisaged that this will be a medium-term contract for the operation of the materials recovery facility which will handle and treat recycling materials. The operation will include, but not be limited to, collecting, transporting, handling, sorting, bulking into containers, transportation to destinations and final disposal of the residual element.

The estimated tonnage to be handled on behalf of Ceredigion County Council is around 6,000 tonnes per annum.
