The North East Lincolnshire Clinical Commissioning Group (NELCCG) in conjunction with North East Lincolnshire Council (NELC) wishes to develop a provision for Voluntary and Community Sector Infrastructure Support in the borough of North East Lincolnshire.

The Contract will be initially set from 1.4.2016 until 31.3.2018 with the possibility of extending the term beyond the initial contracted duration by up to 2 years with mutual agreement from the Provider and NELCCG. This would be dependent on successful achievement of contract outcomes and funding available to support the contract from commissioners.
