Description: Hollolan kunta kilpailuttaa palvelu-, asiointi- ja koululaiskuljetukset. Hankinnan kohteena ovat erilliskuljetukset (koululaiskuljetukset, asiointi- ja palveluliikenne) käytettävine kalustoineen (linja-autot, pikkubussit, taksit) kokonaispalveluna. Hankinta on jaettu osiin. Pääosan hankinnan kohteesta muodostavat liitteen 5 mukaiset reitit. Hankinnan kohteeseen kuuluu myös jonkin verran ylimääräisiä henkilökuljetuksia, esimerkiksi uimahalli- ja retkikuljetukset, joita Tilaja tilaa tarpeensa mukaan. Palveluliikennettä on järjestetty keväällä 2026 seuraavasti ja hankintayksikkö kertoo alla olevat tiedot, jotta tarjoajat voivat arvioida palveluliikenteen osuuden laajuutta. Kyseessä on hankintayksikköä sitomaton arvio joka ei muodosta määräostovelvollisuutta. * Maakansassa on ajettu koulupäivinä oppilaskuljetuksia ja koululaisajojen välissä palveluliikenteen ajoja 3 tuntia/päivä neljänä koulupäivänä viikossa eli yhteensä 12 tuntia/vko auton ollessa muun ajan hyvinvoinnin palvelualueen osoittamissa koululaiskuljetuksissa. Koulujen lomapäivinä on käytössä ollut erillishinnoittelu ja ajotarpeet sovittu erikseen. * Hämeenkosken alueella liikennettä on järjestetty keväällä 2026 kahtena päivänä viikossa, samoin koulujen loma-aikoina. Palveluajoa/kyläkyytejä on ajatettu koulupäivinä 3 h/pv eli 6 h/vko. * Vesikansan alueella palveluajoa on järjestetty koulupäivinä yhtenä päivänä viikossa, 3 h/pv. * Koulujen loma-aikoina koko kunnan alueella kuljetusjärjestelyt on sovittu erikseen ja käytössä on ollut päivähinnoittelu (min. 6 h/pv), jolloin vastaavasti ajoaikaa on ollut enemmän käytettävissä ja liikennöintiä eri suunnille voidaan järjestää tehokkaimmin. Yksi tarjoaja valitaan palveluntuottajaksi korkeintaan neljään (4) osa-alueeseen. Mikäli tarjoaja saa parhaat pisteet yli neljässä osa-alueessa, tarjoaja valitsee kyseisistä osa-alueista neljä, joihin se valitaan palveluntuottajaksi. Muihin osa-alueisiin valitaan palveluntuottajaksi toiseksi eniten pisteitä saanut. Mikäli toiseksi eniten pisteitä saanut tulisi valituksi yli neljään osa-alueeseen, valitsee tämä tarjoaja neljä osa-aluetta joihin se valitaan palveluntuottajaksi jne siten, että yksi tarjoaja valitaan palveluntuottajaksi korkeintaan neljään (4) osa-alueeseen.
