'Qualification Requirement:

Tenderers must be registered in a company register, professional register or a trade register in the country where the tenderer is established.

- Norwegian tenderers: Company registration certificate
- Foreign companies: Verification that the tenderer is registered in a company register, professional register or a commerce register in the country where the tenderer is established'. Norwegian tenderers shall present a 'TAX and VAT certificate'. The tax certificate can be ordered from Altinn, and it must not be older than 6 months calculated from the deadline for submitting a request for participation in the competition or a tender.
