Een datalek kan resulteren in grote schade voor burgers en ketenpartners, en de Staat der Nederlanden. Daarom dient het CJIB te voldoen aan een hoog niveau van informatiebeveiliging. Het CJIB wil met deze opdracht een (sparrings)partner contracteren die, in het geval van een "incident", bij kan springen het CJIB kan ondersteunen met specialistische kennis. In jargon heet dit een incident response retainer overeenkomst. In geval van een ernstig IT security incident is het van belang om zo snel mogelijk met de juiste mensen en partijen te reageren op de situatie en daar waar mogelijk (externe) expertise in te zetten.
