This will contribute to: increased domestic resources for investments in human capital and greater value for money in their use; strengthened macroeconomic management for economic development; progress in addressing the drivers of instability in the context of demographic change; and progress towards a demographic transition and a demographic dividend in the long-term.

The supplier will be required to provide:

— strategic advice, mentoring, technical assistance and capacity development to support reform across key public sector actors through politically informed approaches. This will be a mix of long-term positions and short-term support for specific pieces of work. TA will be accompanied by a flexible fund to support complementary activities.

— support to civil society and investments in public sector transparency, building accountability mechanisms, feedback loops and the capacity of civil society to hold government accountable.
