Justification for the accelerated procedure: ŽURNI POSTUPAK SUKLADNO ČL. 234 Predmet nabave sol za posipanje cesta namijenjen je obavljanju poslova zimske službe, čija je svrha osiguravanje prohodnosti i sigurnosti prometnica u zimskim uvjetima. Potrebe za nabavom soli izravno ovise o vremenskim prilikama (pojavi snijega, leda i niskih temperatura), koje su po svojoj prirodi promjenjive i unaprijed nepredvidive u pogledu intenziteta, trajanja i dinamike nastupa. Sukladno navedenom, u pojedinim situacijama može doći do iznenadnog i povećanog utroška soli, čime se stvara potreba za hitnom nabavom kako bi se osigurao kontinuitet rada zimske službe i spriječila ugroza sigurnosti sudionika u prometu. Kako bi se što prije uspostavio dinamički sustav nabave, sukladno članku 234.
