However, the tender did not present the minimum required quality level. It reached the threshold of 60 points as well as the thresholds of 18 points for criterion 1, 18 points for criterion 2 and 6 points for criterion 4 (quality thresholds) but it did not reach 18 points for criterion 3, and was not further considered in the award process.
