The EAHC/2013/BTSF/12 call was not awarded with a service contract. The offer submitted met the exclusion and selection criteria. However, the tender did not present the minimum required quality level. It reached the threshold of 60 points as well as the thresholds of 18 points for criterion 1, 18 points for criterion 2 and 6 points for criterion 4 (quality thresholds) but did not reach 18 points for criterion 3, and was therefore not further considered in the award process.
