Tackling the obesity rates in Northamptonshire and providing weight management support is a key element of Northamptonshire Public Health's efforts to improve health and wellbeing in the adult population as cited in the 2020 Northampton Health, care and wellbeing plan.

The provider shall provide a digital weight management service that will be available as part of the Tier 2 weight management service in Northamptonshire. This service will provide a minimum of 12 weeks of digital evidence-based support for people to reduce and continue to manage their weight. This must include some form of coaching support alongside the digital intervention.

Tier 4: services are surgical interventions which are available to adults meeting the necessary eligibility criteria
