A single asset delivered shall include a four-wheel-drive vehicle (a pick-up for lot 1 and a van for lots 2 and 3) with a system of surveillance sensors — thermal camera, day camera and surveillance radar (surveillance radar is required only for lot 3) installed on board, as well as a communication

system, including all the necessary devices and software to control the surveillance sensors and the entire system.
