De aan te besteden opdracht omvat enerzijds de levering, inhuizing en montage van los meubilair van het nieuwe gemeentehuis. Anderzijds omvat de aan te besteden opdracht het leveren van werktekeningen van maatwerk meubilair, het produceren, leveren en aanbrengen van maatwerk meubilair.

Het gemeentehuis wordt ingericht op basis van de principes van Het Nieuwe Werken. Dit houdt onder andere in dat er verschillende typen werkplekken (activiteitsgerelateerde werkplekken) te vinden zijn, zoals standaard werkplekken, concentratie werkplekken en samenwerk werkplekken.

De omvang van het project is circa 1 900 m² bvo. De onderverdeling van de inrichting is ongeveer:

- a. Inrichting kantoorruimte met circa 110 werkplekken, bureaustoelen en kasten;
