El Museo Sorolla ubicado en la antigua residencia familiar y taller del pintor Joaquín Sorolla y Bastida en el Paseo General Martínez Campos 39 en Madrid, ha sufrido varias intervenciones para ir adaptando el inmueble al uso museístico. A pesar de las distintas actuaciones, ante la carencia de espacios y dificultades para la correcta accesibilidad en el año 2009 se adquirieron, por el entonces Ministerio de Cultura, dos inmuebles contiguos a la Casa Museo, ubicados en la calle Zurbano, 68, un local en la primera planta cuyos espacios fueron adecuados y ocupados a finales de 2013 y un local en planta baja que se pretende adecuar para su uso museístico, con la dotación de nuevos espacios y servicios. Así mismo, es necesario rehabilitar aquellos espacios originales de la Casa Museo que, por el transcurso del tiempo, la obsolescencia de las instalaciones o falta de algunas infraestructuras fundamentales, necesitan una intervención.

Todas las actuaciones que conforman el objeto de este contrato son imprescindibles para la futura ejecución de las obras indicadas.
