Description: A change of contractor cannot be made for technical reasons linked to interchangeability or interoperability requirements with existing services as ANN is coordinating the manufacturing and FAT activities of the separate subsystems. A change to the supplier would have disproportionate and significant inconvenience and substantial duplication of costs for F4E. The increase in price does not exceed 50% of the value of the original contract.
