Reason for modification: Need for additional works, services or supplies by the original contractor.

Description: Due to the extended programme for delivery of the New Children's Hospital project, a change in contractor providing Community Internal External Stakeholder Engagement and Media Relations Services at this advanced stage of the project (when substantial completion is expected in the coming months) would lead to technical and economic inconvenience and may include a substantial duplication of costs. This is based on the Boards position that a change in Contractor at this stage would result in (i) lost

understanding and knowledge that Q4 Public Relations Limited has gained in the New Children's Hospital project to date; and (ii) it would be costly and time consuming to procure a replacement Contractor at this point. With substantial completion expected within the coming months, the Contracting Authority is of the view that a change in provider at this late stage would be impractical and detrimental to the project from an economic and technical perspective and it is justified to rely on the provisions of Article 72(1)(b) to further extend the term of the contract.

Description of modifications: The Contracting Authority for economic and technical reasons including the inconvenience and duplication of costs in procuring a replacement contractor at this stage of the New Children's Hospital project, intend to extend the existing contract for Community Internal External Stakeholder Engagement and Media Relations Services with Q4 Public Relations Limited to match the new estimated completion date of the New Children's Hospital project
